Venue, Cost and Booking

- 5. The venue for the 2006 conference is the Crowne Plaza Leeds, which has easy access to the M621, M1 and M62 motorways. It is 10 miles from Leeds/Bradford Airport and only a five-minute walk away from Leeds City Centre and its train station. All rooms are en-suite and air-conditioned. **The conference fee in all-inclusive.** All meals from arrival to departure, overnight accommodation at the Crowne Plaza, and all delegate materials are included in the conference fee of £385 plus VAT. Due to the strictly limited number of places available, early booking is highly recommended.
