**The Financial Guidance and Claims Act 2018 (Naming and  
Consequential Amendments) Regulations 2019**

The Secretary of State makes the following Regulations in exercise of the powers conferred by section 1(3) and (4) of the Financial Guidance and Claims Act 2018(a).

**Citation, commencement and interpretation**

1.—(1) These Regulations may be cited as the Financial Guidance and Claims Act 2018 (Naming and Consequential Amendments) Regulations 2019 and come into force on 6th April 2019.

(2) In these Regulations “the 2018 Act” means the Financial Guidance and Claims Act 2018.

**Naming of the single financial guidance body**

2. The single financial guidance body, established under section 1(1) of the 2018 Act, is named the Money and Pensions Service.

**Consequential amendments**

3. The amendments set out in the Schedule have effect.

# SCHEDULE

Regulation 3

## Consequential amendments

### PART 1

#### Primary legislation

2. In Schedule 2 to the Parliamentary Commissioner Act 1967(b) (departments etc subject to investigation)—

- (a) omit “The single financial guidance body.”;
- (b) at the appropriate place insert “Money and Pensions Service.”.

##### **Amendment of the House of Commons Disqualification Act 1975**

3. In Part 2 of Schedule 1 to the House of Commons Disqualification Act 1975(c) (bodies of which all members are disqualified)—

- (a) omit “The single financial guidance body.”;
- (b) at the appropriate place insert “The Money and Pensions Service.”.

##### **Amendment of the Northern Ireland Assembly Disqualification Act 1975**

4. In Part 2 of Schedule 1 to the Northern Ireland Assembly Disqualification Act 1975(d) (bodies of which all members are disqualified)—

- (a) omit “The single financial guidance body.”;
- (b) at the appropriate place insert “The Money and Pensions Service.”.

##### **Amendment of the Pension Schemes Act 1993**

5. In section 175(1)(e) of the Pension Schemes Act 1993(e) (power to make regulations imposing levies to meet certain expenditure) for “single financial guidance body’s” substitute “Money and Pensions Service’s”.

### **Amendment of the Financial Services and Markets Act 2000**

**7.** In the Financial Services and Markets Act 2000(b)—

- (a) in section 3R(4)(a)(c) (arrangements for provision of services) for “single financial guidance body” substitute “Money and Pensions Service”;
- (b) in section 137FC(d) (FCA rules: disclosure of information about the availability of financial guidance)—
  - (i) in subsection (3)(c) for “single financial guidance body” substitute “Money and Pensions Service”,
  - (ii) in subsection (4) for “single financial guidance body’s” substitute “Money and Pensions Service’s”;
- (c) in section 137SA(e) (rules to recover expenses relating to the single financial guidance body) in the heading, and in subsection (1)(a) and (b) for “single financial guidance body” substitute “Money and Pensions Service”;
- (d) in Schedule 1ZA(f) (the Financial Conduct Authority) in paragraph 8(3A) for “single financial guidance body” substitute “Money and Pensions Service”.

### **Amendment of the Freedom of Information Act 2000**

**8.** In Part 6 of Schedule 1 to the Freedom of Information Act 2000(g) (public authorities: general)—

- (a) omit “The single financial guidance body.”;
- (b) at the appropriate place insert “The Money and Pensions Service.”.

### **Amendment of the Equality Act 2010**

**9.** In Part 1 of Schedule 19 to the Equality Act 2010(h) (public authorities: general), under the heading “Industry, business, finance etc”—

- (a) omit “The single financial guidance body.”;
- (b) at the appropriate place insert “The Money and Pensions Service.”.

### **Amendment of the Financial Services Act 2012**

**10.** In section 85(4A) of the Financial Services Act 2012(i) (relevant functions in relation to complaints scheme) for “single financial guidance body” substitute “Money and Pensions Service”.

**11.** In section 18(4) of the 2018 Act(a) (personal pension schemes: requirements to refer members to guidance etc), in the inserted subsection (2A)(b) of section 137FB of the Financial Services and Markets Act 2000(b), for “single financial guidance body” substitute “Money and Pensions Service”.

## **PART 2**

#### **Amendment of the Housing (Right to Buy) (Prescribed Forms) Regulations 1986**

**12.** In the form set out in Schedule 1 to the Housing (Right to Buy) (Prescribed Forms) Regulations 1986(c) for “Money Advice Service: 0300 500 5000; www.moneyadviceservice.org.uk” substitute “Money and Pensions Service: 0115 965 9570; www.moneyandpensionservice.org.uk”.

#### **Amendment of the Personal and Occupational Pension Schemes (Pensions Ombudsman) (Procedure) Rules 1995**

**13.** In rule 2(2) of the Personal and Occupational Pension Schemes (Pensions Ombudsman) (Procedure) Rules 1995(d) (provision of details of complaint made or dispute referred) omit sub-paragraph (d).

#### **Amendment of the Personal and Occupational Pension Schemes (Pensions Ombudsman) (Procedure) Rules (Northern Ireland) 1995**

**14.** In rule 2(2) of the Personal and Occupational Pension Schemes (Pensions Ombudsman) (Procedure) Rules (Northern Ireland) 1995(e) (provision of details of complaint made or dispute referred) omit sub-paragraph (d).

#### **Amendment of the Occupational Pension Schemes (Transfer Values) Regulations 1996**

**15.** In paragraph 3(a) of Schedule 1 to the Occupational Pension Schemes (Transfer Values) Regulations 1996(f) (information to be made available to members) for “Pensions Advisory Service” substitute “Money and Pensions Service”.

#### **Amendment of the Occupational Pension Schemes (Transfer Values) Regulations (Northern Ireland) 1996**

**16.** In paragraph 3(a) of Schedule 1 to the Occupational Pension Schemes (Transfer Values) Regulations (Northern Ireland) 1996(g) (information to be made available to members) for “Pensions Advisory Service” substitute “Money and Pensions Service”.

**Amendment of the Occupational Pension Schemes (Internal Dispute Resolution Procedures) (Consequential and Miscellaneous Amendments) Regulations (Northern Ireland) 2008**

19. In regulation 2(1) of the Occupational Pension Schemes (Internal Dispute Resolution Procedures) (Consequential and Miscellaneous Amendments) Regulations (Northern Ireland) 2008(c) (information requirements)—

- (a) in sub-paragraph (a) for “TPAS (the Pensions Advisory Service)” substitute “the Money and Pensions Service”;
- (b) in sub-paragraph (b) for “TPAS” substitute “the Money and Pensions Service”.

**Amendment of the Local Government (Discretionary Payments) (Injury Allowances) Regulations 2011**

20. In regulation 12(3) of the Local Government (Discretionary Payments) (Injury Allowances) Regulations 2011(d) (notice of decision on reconsideration)—

- (a) in sub-paragraph (d) for “Pensions Advisory Service” substitute “Money and Pensions Service”;
- (b) in sub-paragraph (f) for “Pensions Advisory service” substitute “Money and Pensions Service”.

**Amendment of the Local Government Pension Scheme Regulations 2013**

21. In the Local Government Pension Scheme Regulations 2013(e) in—

- (a) regulation 75(3)(e) (decisions of the adjudicator), and
  - (b) regulation 77(3)(d) and (f) (decisions of the administering authority on reconsideration),
- for “Pensions Advisory Service” substitute “Money and Pensions Service”.

- (b) paragraph 24(a),

for “Pensions Advisory Service” substitute “Money and Pensions Service”.

**Amendment of the Occupational and Personal Pension Schemes (Disclosure of Information) Regulations (Northern Ireland) 2014**

23. In the Occupational and Personal Pension Schemes (Disclosure of Information) Regulations (Northern Ireland) 2014(b) in Schedule 2 (basic information) in—

- (a) paragraph 10(a), and
- (b) paragraph 24(a),

for “Pensions Advisory Service” substitute “Money and Pensions Service”.

**Amendment of the Local Government Pension Scheme Regulations (Northern Ireland) 2014**

24. In the Local Government Pension Scheme Regulations (Northern Ireland) 2014(c)—

- (a) in regulation 85(3)(e) (notice of decisions by the appointed person under regulation 84) for “Pensions Advisory Service” substitute “Money and Pensions Service”;
- (b) in regulation 87(3)(e) (notice of decisions by the Committee under regulation 86), for “Pension Advisory Service” in each place it occurs, substitute “Money and Pensions Service”.

**Amendment of the Company, Limited Liability Partnership and Business (Names and Trading Disclosures) Regulations 2015**

25. In the table in Schedule 4 (specified “public authorities” and list of Government Departments and other bodies whose views must be sought) to the Company, Limited Liability Partnership and Business (Names and Trading Disclosures) Regulations 2015(d) at the appropriate place insert the entry set out in the following table—

- (b) in regulation 12 (the comparisons website) for “Money Advice Service” in both places it occurs, substitute “Money and Pensions Service”;
- (c) in regulation 27(1) (general information on payment accounts with basic features) for “Money Advice Service” substitute “Money and Pensions Service”;
- (d) in regulation 43(1)(b) (evaluation) for “Money Advice Service” substitute “Money and Pensions Service”.

### **Amendment of the Local Government Pension Scheme (Scotland) Regulations 2018**

**28.** In the Local Government Pension Scheme (Scotland) Regulations 2018(b) in—

- (a) regulation 70(3)(e) (notice of decisions on disagreements), and
- (b) regulation 72(3)(e) (notice of decisions on reconsideration of disagreement),

for “Pensions Advisory Service” in each place it occurs, substitute “Money and Pensions Service”.

#### **EXPLANATORY NOTE**

*(This note is not part of the Regulations)*

Regulation 2 of these Regulations names the single financial guidance body, the body established under section 1 of the Financial Guidance and Claims Act 2018 (c. 10) (“the 2018 Act”), as the Money and Pensions Service.

Regulation 3 of, and the Schedule to these Regulations make consequential amendments to legislation as a result of naming the Money and Pensions Service and as a consequence of functions previously carried out by the Pensions Advisory Service and the Money Advice Service now being functions of the Money and Pensions Service (see section 3 of the 2018 Act).

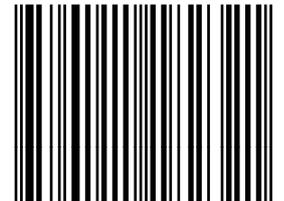
